PREPAY REGISTRATION FOR THE FULL LITTER

General Information and Instructions

PURPOSE Use these applications to register a litter of puppies born from a NAVHDA registered female that was mated to a male of the same breed registered with NAVHDA or a NAVHDA recognized registry. NAVHDA registration policy may be viewed on our web site at www.navhda.org.

Dams not registered with NAVHDA: Complete a *Single Dog Registration Form* available on our website.

MULTIPLE-SIRED LITTERS Contact the NAVHDA office for instructions. DNA certification will be required.

ARTIFICIAL INSEMINATION LITTERS **Fresh Semen:** Use form *Certification of Breeding Using Fresh Semen*.
Fresh Extended Semen: Use form *Certification of Breeding Using Fresh Extended Semen*.
Frozen or Chilled Semen: Use form *Affidavit of Breeding Using Frozen or Chilled Semen*.

FEES Processing fees are nonrefundable and all fees are subject to change without notice.
Litter Registration: The breeder will receive an *Application For Dog Registration* for each puppy in the litter. There will be a \$25.00 processing fee and \$2.00 per puppy charge.
Prepay Litter Registration: The breeder will receive a *Certificate of Registration & Pedigree* for each puppy when the new owner is provided and a *Prepaid Application For Dog Registration* for each puppy when the owner is not provided. There will be a \$25.00 processing fee, the \$2.00 per puppy fee will be waived, and the Dog Registration fee will be reduced from \$15.00 to \$10.00 per puppy.
Late Fee (\$25.00): Required if it has been more than 12 months since the litter was whelped.
Note: If you are paying by check or money order, make payable to NAVHDA.

ADDITIONAL REQUIREMENTS

- If Dam was leased at the time of mating, you must submit a *Leased Dam* notification.
- Effective for litters whelped on or after January 1, 2005, every sire producing seven or more litters in his lifetime or producing more than three litters in a calendar year must be DNA certified through NAVHDA, AKC, or Field Dog Stud Book. These DNA profiles will be used for genetic identification.

Breeding Restriction: If the breeder wishes to indicate dog(s) to be registered with a Breeding Restriction, each individual dog carrying this restriction must be indicated clearly by initialing the box at the end of the registration information line. Each dog that is indicated with a Breeding Restriction will receive this notation on their pedigree. Revocation of this restriction is expensive and time consuming. Be sure when checking this box that you are convinced this restriction is necessary.

It is the breeder's ethical duty to inform the buyer prior to purchase that the dog's registration papers will be printed with a Breeding Restriction. See www.NAVHDA.org under Registry/Breeding Restriction for complete details.
