NAVHDA INVITATIONAL FAQs

Below you will find answers to the questions which have been asked the most regarding the postponement of the 2020 NAVHDA Invitational. If you have any further questions, please contact Angie at invitationaldirector@navhda.org

What are the test dates for the 2021 Invitational being held in Iowa?

- The 2021 Invitational test dates are September 16th through 19th.

If my dog was qualified for the 2020 Invitational, do I need to requalify my dog for 2021?

- No! All dogs qualified for the 2020 Invitational are automatically qualified for the 2021 Invitational in Iowa.
- Dogs qualified for the 2020 Invitational will only have the option to participate in the 2021 Invitational.

If I already submitted an entry for the 2020 Invitational, what are my options for submitting an entry for the 2021 Invitational?

- Your entry/entry fee will automatically be rolled over to the 2021 Invitational and your running day preference will stay in place. You may request a change in your running day preference at any time by contacting Deb at invitationaltestsecretary@gmail.com
- If you would prefer a refund, please contact the NAVHDA office at 1-847-253-6488 or email navoffice@navhda.org by June 30, 2020 and a full refund will be issued.

If I request a refund, how does this impact my ability to re-enter my dog in the 2021 Invitational?

- We know these are trying times. You may re-submit your entry for the 2021 Invitational under the normal entry submission process. You will have from January 1st, 2021 to May 1st, 2021 to send an official test entry form and entry fee into the NAVHDA office.
- Please note, if you do request a refund, your current running day preference will not stay in place and you must submit your preference again when you re-submit your entry. As a result, you potentially may not receive your preferred running day.

If I didn't already submit an entry for the 2020 Invitational, what is the entry submission process for the 2021 Invitational?

- If you received an invitation to the 2020 Invitational you will need to follow the normal entry submission process for the 2021 Invitational. You will have from January 1st, 2021 to May 1st, 2021 to send an official test form and entry fee into the NAVHDA office.

If my dog receives a qualifying Utility score in 2020, what are my options for participating in the Invitational

- Dogs receiving a Utility Prize I qualifying score in 2020 will be eligible to participate in the 2021 Invitational in Iowa or the 2022 Invitational hosted by the Zia Chapter in Albuquerque, New Mexico.
- Dogs already qualified for the 2020 Invitational will only have the option to participate in the 2021 Invitational in Iowa.
